Annual General Meeting:-

Jeff Smith welcomed members to our second face to face meeting and stated that it was particularly nice to see Roger Goodhew and Robert Knight who had been unable to participate remotely.

Election of Officers:

Michael Williams proposed that Jeff Smith be re-elected to the chair. This was seconded by Roger Whitehouse and agreed by the meeting.

The meeting received notification from Ivor Morris that he wished to step down from Vice-Chair. Jeff Smith proposed Angus Eickhoff for Vice-Chair and Ivor Morris for committee member without portfolio. This was seconded by James Davies and agreed by the meeting.

Michael Williams proposed that Bill Redfern continue as Treasurer and Membership Officer. This was seconded by Jeff Smith and agreed by the meeting.

Despite requests for volunteers the office of Secretary remains vacant.

Robert Knight proposed that Denis Bates continue as Newsletter Editor. This was seconded by Jeff Smith and agreed by the meeting.

Jeff Smith proposed that Robert Knight continue as Distribution Officer. (Robert requested that he be given maximum notice of publication.) This was seconded by James Davies and agreed by the meeting.

Jeff Smith proposed that Angus Eickhoff continue as Web Master. This was seconded by Robert Knight and agreed by the meeting.

Jeff Smith proposed that Roger Goodhew and Tony Harvey continue as Committee Members without portfolio. This was seconded by Robert Knight and agreed by the meeting. The meeting recognised Tony Harvey's recent success in achieving a doctorate.

Bill Redfern proposed Thomas Wheeler and Roger Whitehouse as Committee Members without portfolio. This was seconded by Jeff Smith and agreed by the meeting.

Treasurers Report:

Bill Redfern presented a summary of the associations finances, attached.

Though income and expenditure are roughly balanced (over the 18 months since the last report) it is too close for comfort, and we should be aiming to build up funds for campaigning. This reflects that the membership renewals are currently low at 30, renewals continue to come in throughout the year. We all need to encourage more members to join.

Angus Eichoff pointed out that we have more subscribers to our Facebook pages than actual members, but it is not clear how to encourage them to join.

Bill Redfern proposed that we increase the number of cheque signatories, on a any 2 signatures required basis; and accordingly that the signatures of Roger Whitehouse and Jeff Smith be added. This was seconded by Jeff Smith and agreed by the meeting. Jeff Smith took an action to ensure that councils along the coast are aware. It was though that Trevor Roberts may be able to help encourage membership along the Coast Line.

Scope:

Bill Redfern proposed that we formally confirm that the scope of the association includes the Cambrian Coast Line. This was seconded by Jeff Smith and agreed by the meeting.

It was noticed that it is proposed that there will be no trains at all on the Coast Line during the Autumn Barmouth Bridge works. It was considered that bustitution should be minimised and that trains should be considered at least to Tywyn.

It is rumoured that problems have been identified with the running of the new 197 trains along the Coast Line.

The importance of through journeys from the coast was reiterated.

We hear that TfW have purchased shortened HST sets for summer use between Manchester and Llandrindod. Why not the Cambrian?
